

## Facebook Fall Giveaway Official Rules:

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- 1. Entry Period:** Sweepstakes ends November 7, 2018 at 11:59 pm ET (the "Fall Giveaway Period"). Administrator's computer is the official time keeping device for this Sweepstakes.
- 2. Eligibility:** The Fall Giveaway is open to legal residents of the fifty (50) United States (including the District of Columbia) who are eighteen (18) years of age or older as the date of entry ("Entrant").
